

Donor Privacy Policy

It is the policy of St. Patrick Center to respect and protect the privacy of individuals both online and offline. This Privacy Statement describes how St. Patrick Center collects, uses, and shares personal information obtained when you donate using our website. By donating through this website, you assent to the St. Patrick Center Privacy Statement. If you do not agree to this Privacy Statement, please contact us about any alternative arrangements for donating.

How We Collect, Use and Share Donor and Registration Payment Information

Donation processing for St. Patrick Center is handled by our third-party service provider. St. Patrick Center's website donation form will request that you provide certain contact information, including your name, mailing address, phone number, and e-mail address. In addition, St. Patrick Center's donation form will request that you provide certain donation information, including the amount of your donation. Finally, St. Patrick Center's donation form will request that you provide certain billing information, including the name of your bank or credit card, your bank or credit card account number, expiration date, and billing address. St. Patrick Center does not have access to bank or credit information once it is submitted.

The service provider that processes your donation or registration will use the information that you provide for the following purposes:

- To process your donation or registration payment request
- To verify your identity
- As otherwise specified in the service provider's Privacy Statement 1 and Privacy Statement 2.

The following only applies to online donations: The service provider will share your contact and donation information with St. Patrick Center. However, St. Patrick Center will not request or receive your billing information. St. Patrick Center to which you make your donation or registration payment may use your contact and donation information for the following purposes:

- To contact you about your donation and future donations
- To perform any necessary tasks required or permitted under applicable law

In addition, St. Patrick Center to which you make your donation may publish your name and donation level in its donor rolls. If you wish for your donation to remain anonymous, you must indicate on the online donation form or contact St. Patrick Center to let us know your request of an anonymous donation.

St. Patrick Center does not sell or rent the personal information you provide on the website to anyone. St. Patrick Center may be required or permitted by applicable law to disclose your personal information to the

government or third parties under certain circumstances. We reserve the right to respond to any subpoena received from a government agency without prior notice to you. Additionally, if we need to investigate or resolve possible problems or inquiries, we may disclose certain information about you to private entities, law enforcement, or other government officials as St. Patrick Center, in its sole discretion, believes necessary or appropriate.

Privacy Practices of Third Parties

Cookies

St. Patrick Center's website may use "cookies" to automatically gather some information about you, or to offer a personalized experience on the website. A cookie is a small text file that the system sends to your computer to collect information about your activities on the Web site. The cookie transmits this information back to the website each time your browser requests a page from the website, and the information may be stored to help facilitate your use of the website the next time you visit. If you do not want to receive cookies from the website, you can set your browser to not accept cookies.
